POST OF CHIEF EXECUTIVE OFFICER

The Mauritius Cane Industry Authority, set up by the Mauritius Cane Industry Authority Act No 40 of 2011, is a parastatal body operating under the aegis of the Ministry of Agro-Industry and Food Security.

Applications are invited from qualified candidates who wish to be considered for employment as Chief Executive Officer on a **contractual basis** at the Mauritius Cane Industry Authority (Ref: CEO/018).

II. AGE LIMIT:

Candidates should not have reached their 65th birthday by the closing date for submission of application.

III. QUALIFICATIONS:

- (i) possess a Master's Degree in any Science subject or Agriculture or Economics or Management or Finance or Law or Accountancy or Sugar Technology or Engineering from a recognised institution or an equivalent qualification acceptable to the Board;
- (ii) reckon at least ten years' experience at senior management level;
- (iii) have the ability to think proactively, critically and strategically;
- (iv) possess excellent leadership, management, communication and interpersonal skills;
- (v) have highest commitment to achieve strategic objectives falling under his responsibility; and
- (vi) be computer literate.

Candidates should produce written evidence of experience/knowledge claimed.

IV. ROLE AND RESPONSIBILITIES:

To be responsible to the Board for the execution of the policy of the Board, the overall administration and management of the Mauritius Cane Industry Authority.

V. MAIN DUTIES:

To advise the Board on the formulation of appropriate legislation in line with government policies and also on the introduction of new technology and modernisation of the cane sector for increased viability.
